Pandao (hereafter also “We”) offers online Software as a Service (SaaS) through the website <https://pandao.pro> (hereafter – “Website”). Our software (hereafter – “Software”) enables you to invest in cryptocurrencies using an automated crypto trader bot, allowing you to calculate your monthly ROI based on the affiliate plan attached to these terms.

These terms and conditions (hereafter – “Terms”) govern the relationship between Pandao and Users (hereafter – “you”) for any use of the Website and the Software provided by Pandao. Use of the Website or Software is prohibited without accepting these Terms.

1. Definitions

- **Company:** Pandao.
- **User(s):** A private person(s) using the Website or Software.
- **Software:** The automated crypto trading software developed by Pandao. It is accessible via the Website <https://pandao.pro>.

2. Registration and Personal Account

2.1 To use our Website and Software, register and create a personal account at <https://pandao.pro>.

2.2 You must protect your login details and keep your password strictly confidential. Actions taken from your account will be assumed to be by you or authorized by you.

2.3 You agree to provide accurate, complete, and up-to-date information and update your account as necessary for us to contact you.

3. General Information

3.1 The Website can be used free of charge.

3.2 We reserve the right to change the free usage terms in the future, but changes will not retroactively affect existing free access.

3.3 If you do not enable auto-invest lock, your membership and all ROI functionalities will be deactivated after each 90-day cycle.

3.5 We are not responsible for any fees or commissions imposed by third parties related to your participation in cryptocurrency trading.

4. Withdrawal

4.1 Users can withdraw their funds subject to the 90-day locked trading cycle.

4.2 Withdrawing will cancel your active status and your ability to earn commissions under the affiliate plan.

5. Fair Use of the Website and Software

5.1 Users must be at least 18 years old to use the Website and Software.

5.2 Prohibited actions:

- Using the Website or Software in violation of laws or regulations.
- Using the Website or Software from restricted countries, including:
